Member requests disenrollment for any reason. ⁱⁱⁱ Member requests for disenrollment may include requests to transfer to IRIS, which requires coordinating IRIS start date with MCO disenrollment date, generally at change of calendar month. 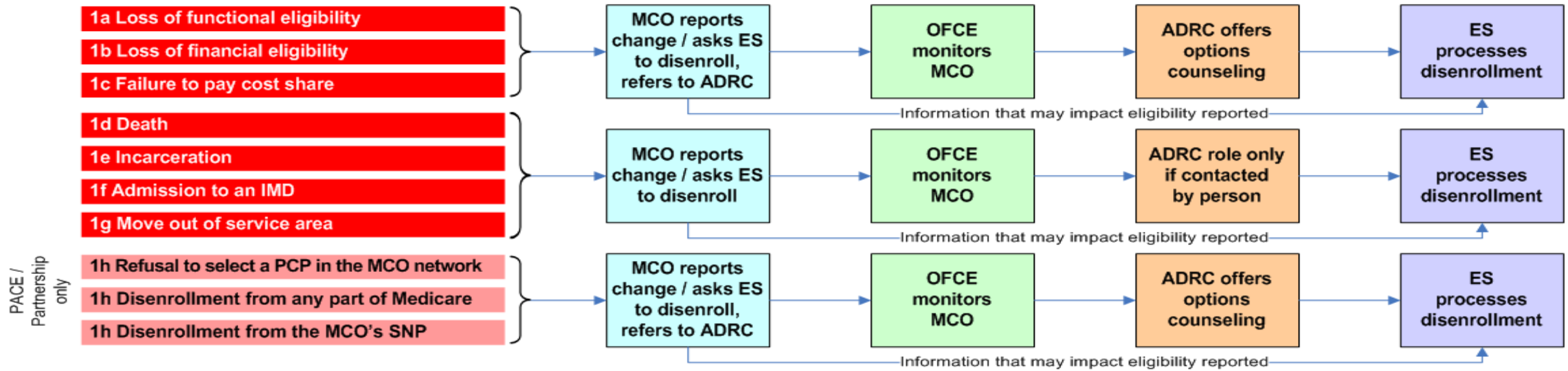
ⁱ If through disenrollment counseling, the ADRC is able to intervene on the member's behalf to restore eligibility, or the consumer chooses to withdraw their request to disenroll, the ADRC will communicate ES and the MCO to restore services before the end date. There is a very limited window for the ADRC to stop the disenrollment.

ⁱⁱ MCO contracts also require MCOs to send a notice of action whenever services are reduced or terminated

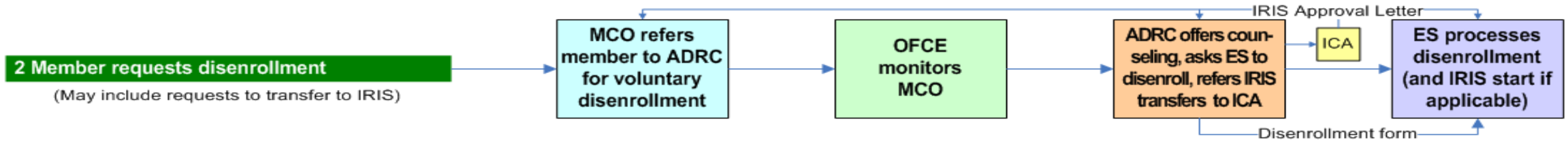
ⁱⁱⁱ Member requests disenrollment for any reason – if there is no ADRC in the county, the MCO will send the disenrollment form to ES and the MCO's should help transition the disenrolling member.

Processing Disenrollments in Managed Long Term Care

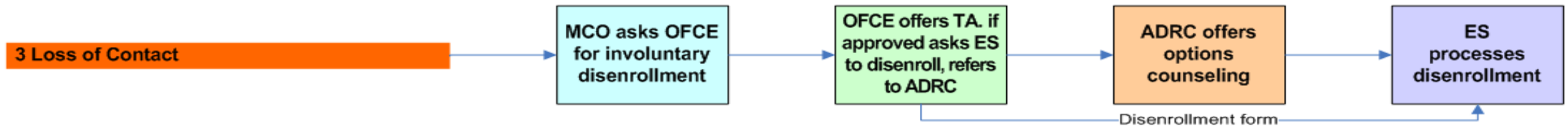
Loss of Eligibility Disenrollments
