Health and Safety Committee April 4, 2012

“Is UW Oshkosh Ready to Adopt a Tobacco-Free Campus?”

There is an initiative currently underway, to explore the readiness of campus to become a tobacco-free campus. The committee's work is sponsored by the Health and Safety Committee, through assistance from a small grant.

The following is a draft timeline of activities planned primarily by the small task force, and in collaboration with the sponsoring Health and Safety Committee.

Tentative Timeline of Events

Spring 2012

- Planning by a small task force appointed by Health and Safety Committee.
- A minimum of two (2) media activities will take place (eg. – press releases, spot on Titan TV, page on UWO website, Facebook page created, etc.)
- Task Force will create a campus-specific powerpoint introducing the TFC concept and begin planning potential events and other opportunities to present this information to organizations and the general campus population.
- Develop a campus survey to gather campus opinion data about the potential of a TFC.
- Begin discussion with the HR Office and various work units about the potential impact of a TFC on our employees. Develop a plan to hear concerns, and gauge support or opposition.

Fall 2012

- Hold additional media activities throughout the semester (minimum of two more).
- Administer the campus survey in late September. Once results are tabulated, utilize this information to help people understand current opinion.
- Hold at least four (4) presentations or forums on the TFC concept. The goal is for each of these presentations to be for a minimum of 150 students, faculty, and staff.
- Review and share policy that could be developed for UW Oshkosh by reviewing what has been done on other campuses.
- Work with campus governance groups to develop a plan for a resolution to be sponsored and voted by each campus governance group (OSA, Faculty Senate, CSAC, and Senate of Academic Staff) by end of fall semester.
- Based on the campus discussions, opinions, and governance process, review the results with campus administration to present a recommendation and determine next steps.
