I worked closely with the Provost, the President and the Cabinet, Finance, Student Affairs, Deans, and the Faculty Senate. My office worked to enhance and expand graduate programs and to increase sponsored research funding. Prior to

serving in that role, I served as the Director of Sustainability Studies and developed new undergraduate and graduate programs in sustainability.

**Interim Associate Dean for Faculty.** University of South Florida (1990-2011). I served in a variety of administrative roles at the University of South Florida including Associate Dean for Faculty in the College of Arts and Sciences, Chair, and Graduate Director.
